300 Years Ago the Nellises Arrived

In 1725, Christian Nellis (28 years old), Barbara (27 years old, also known as Barvalis Klock), and two or three of their children relocated to the 640-acre Lot #12, within the Harrison Patent on the Mohawk River.


The land from the river's edge to the hills beyond was covered with a thick forest. Christian, Barbara, and their 7-year-old son Henry began clearing the forest and used the cut trees to build a one-room dwelling and possibly some sheds. As they cleared more land, they grew wheat to sell to the British in New York and cultivated crops to feed their family. They also became involved in the developing community that would later become St. Johnsville.

After twenty years near the riverbank, Christian and Barbara had accumulated enough wealth to have built a new home on the north side of the King's Highway away from the river. The family, which now included six children at home (three had grown and moved out), left their small cabin for a larger dwelling. The new house had a fully dug cellar with a large fireplace and a cold storage room, a ground-level floor with two rooms each featuring a fireplace, a center hall, and a loft above for food storage and sleeping. Quite the fancy place for its time.

According to historian Simms, Christian was the head of a wealthy family in the Palatine District. At age 70, Christian transferred much of his portion of the Nellis and Klock Patent to his son, Christian Jr. He lived for about four more years and is buried with Barbara in the Klock graveyard east of St. Johnsville.

The story could go in many directions: following the Nellis family in their new home, exploring Christian Jr. and his exceptional sons, tracing the development of the Palatine District, or focusing on the Palatines who contributed to New York's growth.

Perhaps the Christian Nellis first home near the Mohawk River looked like this.

Recently, we (the PSS) were gifted a small booklet by Jan Gilliam, a relative of its original owner. On its pages were signatures of the friends of "May E Nellis" from around 1886. Who was this young lady? Was she in THE BOOK? A puzzle for Sandy Lane and John Case. They searched the Nellis/Nelles books with little success for several weeks, until ... You guessed it ... She is!

She was Mary Elena "May E" Nellis who was born and raised on the farm a half mile west of School #8 on the opposite side of the New Turnpike. She lived on her parents, John Adam and Lovina Nellis's farm with her three brothers until she married. They most likely each attended School #8 for a time. This farm was owned in the late 1900's by Bernard Seeley and family, good friends of PSS.

As the Nellis kids matured, brother Amon P. Nellis moved to the farm just west of the school. It was owned more recently by Herbert and Phyllis Mueller. Phyllis donated School #8 and the lot it resides on to the PSS.


Brother George Mahlon Nellis moved to a farm along Route 5 on the western edge of the village of St. Johnsville. He bottled milk for sale at that farm. The farm has since belonged to Donald Nellis and is now owned by Gary Stowell.

Finally, oldest brother Ira John Nellis moved to their grandfather Ira Nellis's farm east of School #8 at the corner of Suits Road. This farm later was owned by C. J. Settle, father of Harold and three sisters. Sister Janet Settle Shuster who recently passed, attended School #8 in 1945, the year the school was closed. She helped us with much history about the school. That farm is now owned and occupied by John and Patricia Case.



May E's autograph booklet now resides in School #8 along with a G M Nellis milk bottle. Why don't you stop in during the summer to

see them and explore the many other artifacts that have accumulated and are on display there? It is worth the visit.
